



Market Summary

The stock market on Monday remained negative in majority part of the day and concluded the session in the red zone amid profit taking exerted downward pressure, eroding earlier gains made on the previous trading day. The Benchmark KSE-100 index made an intra-day high and low at 78,886.46 (316.88 points) and 77,940.52 (-629.06 points) respectively while closed at 77,980.29 by losing 589.29 points. PKR in today's interbank depreciated by Rs 0.0923 against USD and closed at Rs 278.6423. The value of shares traded during the day was Rs22.233billion. Market capitalization stood at around Rs10.382 trillion. Overall, trading volumes for the day decreased to 414.56 million shares compared with Friday's tally of 420.07 million. YOUW was the volume leader with 38.1 million shares, gaining Rs1 to close at Rs5.34. It was followed by WTL with 19.2 million shares, gaining Rs0 to close at Rs1.17 and KOSM with 13.3 million shares, gaining Rs1 to close at Rs7.64.
