


Market Summary

The stock market on Thursday opened on a positive note. However, earlier gains were eroded in the second half and concluded the session in the red zone amid profit taking by the investors. The Benchmark KSE-100 index made an intra-day high and low at 120,699.17 (767.72 points) and 119,062.03 (-869.42 points) respectively while closed at 119,153.04 by losing 778.41 points. PKR in today's interbank depreciated by Rs 0.0961 against USD and closed at Rs282.0635. The value of shares traded during the day was Rs30.794 billion. Market capitalization stood at around Rs14.381 trillion. Overall, trading volumes for the day decreased to 588.52 million shares compared with Wednesday's tally of 667.10 million. KEL was the volume leader with 42.8 million shares, losing Rs0.04 to close at Rs4.71. It was followed by BML with 28.2 million shares, gaining Rs0.34 to close at Rs3.77 and GGL with 27.6 million shares,gaining Rs1.12 to close at Rs16.71.


